Sealed tenders are invited for approximately **8966** numbers of Ladies Bi-cycles approximately with ISI mark or confirming to IS specifications completely assembled with accessories.

TERMS & CONDITIONS

1. The upper price limit of the Bi-cycle will not exceed @ Rs.2000/- inclusive of all taxes and transportation cost.
2. (a)The tender documents can be purchased from the office the District Social Welfare Office, Collectorate, Kandhamal during the Office hour by depositing Rs.2000/- only or it can be downloaded from the website, www.kandhamal.ori.nic.in/ [www.wcdorissa.gov.in.](http://www.wcdorissa.gov.in)

(b) In case the tender documents downloaded from the websites , the Tender Document Fee of Rs.2000/- must be deposited alongwith the Technical Bid in the form of a Demand Draft, drawn on a scheduled bank, in favour of Collector, Kandhamal and payable at Phulbani.
3. The tenderers should deposit **EMD of Rs.200000/- (Rupees Two lakh)** only in shape of Bank Draft payable in favour of District Social Welfare Officer, Kandhamal alongwith the tender paper failing which his/her tender paper will not be considered.
4. A logo indicating the word **"Govt. of Orissa" & "Not for Sale"** should be superscribed on the body of each Bi-cycle.
5. The tenderers should specifically mention the name of the brand of the Bi-cycle and features of the Bi-cycle, and the Bi-cycle confirm to the technical specification given in the tender schedule.
6. The successful tenderer shall have to supply the Bi-cycles within ten days from the date of placement of supply order failing which the order of supply shall be deemed to be forfeited. Number of Bi-cycles may vary as per requirement.
7. The successful tenderer shall have to deliver the Bi-cycles to the Block Development Officers at his own cost at Block Offices (12).
8. One sample of the Bi-cycle to be produced by the tenderers at the time of opening of tenders.
9. The Sealed tender papers should be sent by speed/Registered Post to the DSWO, Kandhamal or to be dropped in the box kept for the purpose in the Dist. Social Welfare Office, Kandhamal.

10. The sealed tender will be opened on **13.08.2008 at 5.00 PM** in the Office of the Collector, Kandhamal in presence of members of the Tender Committee and the tenderers or their authorized representatives.
11. The last date of receipt of sealed tender papers is on or before **11.08.2008 by 5.00 P.M.**
12. The authority reserves the right to reject any or all quotation/supply order without assigning any reason.
13. The no.of bicycles indicated above is tentative and the actual number will vary. Payments will be made to the selected agency only of such number of bicycles actually be needed to distribute.
