Sub: Enhancement of grinding charges of wheat under
Wheat Based Nutrition Programme (SNP).

Sir,

I am directed to intimate that the question of enhancement of rate of grinding charges of wheat under Wheat Based Nutrition Programme (SNP) was under consideration of the Government for some time past. Government in C.D. & R.R. Department, Orissa (earstwhile Deptt.) in letter No.6262/NTN dt.5.8.97 have fixed the rate of grinding charges of wheat as Rs.15/- per quintal. In the meanwhile, the labour charges and electricity charges have been enhanced and it would not be possible to grind wheat at the rate of Rs.15/- per quintal as approved earlier.

Therefore, after careful consideration of the rate of hike in the electricity charges, labour charges, other incidental charges, etc. it has been decided to enhance the grinding charges of wheat under Wheat Based Nutrition Programme (SNP) from Rs.15/- per quintal to Rs.55/- (Rupees fifty five) only per quintal. The rate of grinding charges now enhanced is inclusive of loading and unloading charges of wheat sent for grinding. Grinding charges will be met out of the T.D. Rs.0.10 paise (ten paise only) per beneficiary per day earmarked in the ration cost of S.N.P. feeding. No extra funds will be provided towards grinding charges.

The Collectors may adopt tender procedure for selection of the mill for grinding the wheat under the scheme. No shortage in the process of grinding shall be allowed. In case of any difficulty in adopting the above procedure, the Collectors are requested to obtain order of the Govt. for making any other arrangement.

This has been concurred in by the Finance Department vide their UOR No.481/SS II dt.9.10.2000. The enhanced rate will be applicable from the date of issue of this letter.
