RESOLUTION

No.II-CW-7/2004. 15186 /W&CD, Dt. 7.8.2004

Subject. - Revision of Maintenance Grant for the inmates of Orphanages.

In supersession of this Department Resolution No.4831/ dt.22.5.1997 Government after careful consideration have been pleased to revise the existing rate of grant-in-aid from Rs.300/- to Rs.500/- (towards 90% contribution) payable to the Voluntary Organisations (Orphanages) with effect from the date of notification under Rule-5 of "The Orissa Maintenance of Orphanages Rules 1985".

2. After revision the Voluntary Organisations (Orphanages) are eligible for grant-in-aid in the following manner per month per inmate with effect from the date of notification.
