1. After detail discussion regarding procedures adopted for processing of proposal for Grant-in-Aid, it was decided that:-
  - a. The special school funded by State Govt. should be recommended through Screening Committee.
  - b. List of ongoing proposal running under Women & Child Development Department should be submitted to Screening Committee after proper scrutiny by the concerned sections and Branch Officers if found suitable for recommendation.
  - c. Register should be maintained by the concerned section with detail of the organization regarding receipt of proposals and their processing separately both for new and on-going.
  - d. The concerned section should open individual file for individual proposal.
  - e. Incomplete proposal; should be complied by the concerned Branch before placing the same to Screening Committee.
  - f. The proposals received by MVSN should scrutinize the same before submission of the same to the concerned section. The proposals received directly by the section should be scrutinized in the section without sending it to MVSN.
  - g. Children/Disable Children are staying with their mother in destitute homes running under Women Welfare Section. The concerned organization should be registered under WD Act, and J.J Act.
